A portion of the route from Ramanattukara to 11th Mile in a distance of 2 kms is overlapping the notified sectors Palakkad – Kannur and Kozhikkode –Vazhikkadavu.

In view of the notification No. 42/2009 dated 14.07.2009 since the overlapping on the notified route is exceeding the permissible limit. Hence the application for regular permit is rejected.

Item No.11

Heard. Rejected the application for regular permit since the offered vehicle is a four wheeled. As per the direction of STA No.D2-391/STA/2007 dated 03.03.2009 that the Stage Carriage permit shall not be issued. Renewed or countersigned in respect of vehicles having less than 6 wheels, two in the front and four in the rear axle.

As per previous decision of RTA dated 22.07.2009 subject to settlement of timings.

Item No.21

Heard. Proposed additional trip is overlapping the notified sector Kottayam Kozhikkode, in view of the notification No. 42/2009 dated 14.07.2009 SRO No.313/67 from Eramangalam to Puthanpalli having a distance of 2 Kms and the terminus will change on the change of halting place. It violates section 80(3) of KMV Rules. Hence Rejected.

Item No.22

Heard. Intention of permit holder is to change existing timings. And MVI reported that the route is a well served area. There are 36 stage carriage services and 102 trips with a time gap of 10 minutes, route covered by 282 kms with a running time 11 hrs and 45 minutes. Hence application for regular variation is rejected.

Heard. Adjourned. Secretary is directed to submit a specific report whether the curtailment will adversely affect the traveling public.

Heard. Intention of permit holder is to change existing timings. There is no variation of permit in the application and there is no new circumstance to change of existing timings and permit. Hence rejected.
