

ORDER NO.C8/(D3)/ KL 10 R 9779/2013/ M DATED 29/01/2016

In compliance to the direction of Hon'ble High Court of Kerala in the judgment dated 17.05.2005 in OP No.12774/97, State Transport Authority, Kerala has decided to implement new rate of running time for stage carriages operating in the state by considering various parameters such as nature/type of road, area, class of vehicle etc as per the proceedings mentioned in 2nd reference. It was directed by Transport Commissioner, Kerala to implement the above decision of STA. The Regional Transport Authority, Malappuram in its meeting held on 14.12.2011 also directed the undersigned to implement the order of State Transport Authority. The judgment of High Court of Kerala in the 3rd reference further directs the Regional Transport Authorities in the State to give effect to the provisions of decision of STA, Kerala in a time bound manner.

In obedience to the above orders, enquiry was conducted through field officers to fix the running time in accordance with the nature of roads. Meeting with the representatives of all bus owners associations of the district was conducted to discuss regarding the implementation of the above order. Since it has become pertinent in terms of safety of commuters of stage carriages and road users, as informed in the 4th reference, the undersigned is here by issue fresh set of tentative timings as per reference 2 above in respect of above stage carriage operating on the route mentioned. The below fresh timings in accordance with STA order no D3/875/2005/STA dated 08/11/2011 will come into force with effect from 25/02/2014, and objections if any against the timings can be filed by the concerned to the under-singed within a period of 03 month
